## Cancellation Policy

### 1. Cancellation on or Before September 30, 2025

A family that gives the JEC a written notice of cancellation on or before September 30, 2025, and completes the [IsraelNow withdrawal form](#) will be eligible for a **full refund**.

### 2. Cancellation between October 1, 2025, and October 30, 2025

A family that gives the JEC a written notice of cancellation between October 1, 2025, and October 30, 2025, and completes the [IsraelNow withdrawal form](#), will be eligible for a refund of \$500.

### 3. Cancellation after October 31, 2025

**No refunds** will be granted after October 31, 2025. A family must still complete and submit the [IsraelNow withdrawal form](#) to formally withdraw from the program.
